- Investigating trends and emerging research related to the need for and impact of homeownership and financial education and other program related topics to enhance grant proposals
- Write grant proposals, reports and thank you letters to funders
- Aggregating, analyzing and compiling various participant survey information
- Geocoding program data to develop heat maps and illustrate trends and programmatic impact

- Researching key economic and community development initiatives of local and state government to assess alignment with SCH strategic directions
- Working with Spanish Coalition for Housing staff to outline priority programs and projects
- Assists with coordination, promotion and logistics of special agency events
- Assists with special mailings or targeted marketing campaigns
- Support content development for digital media, including social media and e-newsletter
- Performs other duties as assigned/special projects as assigned
